5.1 Approval of Director's Contract

Mr. Mashmeyer stated that the public was given the opportunity to review the proposed contract for Dr. Edds, Director at last month's meeting. He then stated that the contract is being brought to the Board for action.

Gwen Freeman moved for approval of the Director's Contract. Greg Waltz seconded the motion. Motion passed 5-0.

5.2 Approval of Memorandum of Understandings

Minutes

Dr. Edds presented the Board with two memorandum of understandings that he worked on with the C9 Teacher's Association. One was to clarify a base rate for any additional non instructional work done by a certified employee to be paid at the rate of \$35.00 per hour. The other memorandum is to clarify pay for teachers who sponsor competitions.

He explained that the way the contract was originally written paid an extremely high rate of pay to the first teachers who attended competitions and then there was no money left for others who went later in the year. After discussion with Mr. Paprocki, C9 Teacher's Association President, it is being proposed in the Memorandum that for instructors who work with students during non instructional hours to prepare or accompany students for a competition, they will be paid a \$500.00 stipend for the first level and if they advance to a level beyond that, they will be paid a one time stipend of \$250.00. The maximum amount payable to any one instructor during a school year will not exceed \$750.00. Mr. Paprocki then publically agreed with Dr. Edds' explanation and the Memorandum of Understanding.

Chris Wood moved for approval of the Memorandum of Understandings. Carol Tumey seconded the motion. Motion passed 5-0.

5.3 Approval of Donated Vehicle for Charity Program

Dr. Edds introduced Mr. Ed Callico the new Auto Collision Repair Instructor. Mr. Callico explained that his Skills USA students would like to present the Board with a proposal to facilitate a charity program. Andrew Creek, Franklin Central High School and Austin Hamburg, Perry Meridian High School then presented the Board with a handout from the National Auto Body Council regarding the Recycled Rides for Schools Program. They explained that the program would allow their Auto Collision Repair program to restore a vehicle to give to a needy individual. Mr. Callico outlined in depth the guidelines of the program. He stated that Central Nine would not carry any liability of the vehicle because they would never possess the title. He informed them that after the vehicle was complete, there would be a media day where the vehicle would be presented to the individual who was chosen to receive the vehicle.

Gwen Freeman moved for approval of the Donated Vehicle for Charity Program. Greg Waltz seconded the motion. Motion passed 5-0.

A discussion was held on the promotional benefits of such events like this being held at Central Nine. Dr. Edds stated that the promotional trailer is actually at a middle school football game this evening. Mr. Maschmeyer suggested that we invite home school journalism students to the Board meetings to do an article on the student showcases each month to help promote Central Nine at the home schools. Dr. Edds stated that a joint meeting of the Principals, Curriculum Directors and Counselors would be held on Friday, September 12th and they would bring the proposal to them at that time.

Mr. Paprocki, Computer Technology Instructor presented the Board with a proposal for a 24 hour robotic competition called "Lock Tight Night". He explained that Central Nine had participated in the program when it was hosted at Indian Creek last year and would like support from the Board to host the event at Central Nine this year. He explained that the competition takes place over a 24 hour period. When the student teams arrive, they are given a robotic challenge. They then have until the next morning to complete the challenge. They then compete against other teams in a qualifying event. If they qualify, they then compete their robots against robots constructed by teams of actual engineers. He also stated that he has requested the involvement of other Central Nine programs i.e. Culinary Arts will be preparing food that the students can purchase, Criminal Justice students will be monitoring hallways and exits and the EMT students will be providing any minor health care. It was the consensus of the Board to support "Lock Tight Night".


